**Title:** Professor of Sociomedical Sciences (in Social Work) at Columbia University Medical Center, Adjunct Full Professor, Teachers College, Associate Dean for Community and Minority Affairs

**Bio:** Robert E. Fullilove, EdD has authored numerous articles in the area of minority health. From 1995 to 2001, he served on the Board of Health Promotion and Disease Prevention at the Institute of Medicine (IOM) at the National Academy of Sciences. He has served on five IOM study committees that have produced reports on a variety of topics including substance abuse and addiction, HIV/AIDS, tuberculosis, and damp indoor spaces and health. In 2003 he was designated a National Associate of the National Academies of Science. In 1998 he was appointed to the Advisory Committee on HIV and STD Prevention (ACHSP) at the Centers for Disease Control, and in July, 2000, he became the committee's co-chair. He served on the National Advisory Council for the National Center for Complementary and Alternative Medicine at the National Institutes of Health [NIH]. Since 2010, he has been teaching public health courses in six New York State prisons that are part of the Bard College Prison Initiative (BPI) and serves as the Senior Advisor to BPI's public health program. Dr Fullilove serves on the editorial boards of the journals Sexually Transmitted Diseases, and the Journal of Public Health Policy and has been awarded the Distinguished Teaching Award at the Mailman School of Public Health three times. In 2002, he was awarded an honorary doctorate from Bank Street College of Education.

**Bio:** Ms. Chodon, BSN, MPH has over thirty years of experience with various government and non-government organizations in population health program design, development, management, and oversight. Her work has included programs in smoking cessation, asthma, epilepsy, HIV/AIDS prevention, and other chronic disease prevention and management. As the CPHO at BCHN, she leads the growing Community Health and Wellness Program through transition toward population health improvement, driving greater accessibility and growth in healthcare delivery and prevention and health promotion. She oversees the operations and quality of BCHN community health and wellness programs and services, ensures that appropriate infrastructure is in place to support current activities and projected growth.



**Kevin Fiori MD, MPH, MS**

**Title:** Vice Chair for Community Health & Engagement, Director of the Community Health Worker Institute at Montefiore Health System, Associate Professor, Albert Einstein College of Medicine

**Bio:** Kevin Fiori MD, MPH, MS is the Vice Chair for Community Health & Engagement and inaugural Division Chief for the Division of Community and Population Health within the Department of Pediatrics, Director of the Community Health Worker Institute at Montefiore Health System, Director of Social Determinants of Health for Montefiore Health System's Office of Population and Community Health, and Associate Professor in both Pediatrics and Family and Social Medicine, Albert Einstein College of Medicine. His research aims to address health disparities in communities both in the Bronx and abroad and he is primary investigator on multiple ongoing implementation research studies in Togo, West Africa and the Bronx, particularly focused on community health worker integration within health systems. He is a founding member of the Community Health Impact Coalition that aims to make professionalized community health workers a norm worldwide and is a co-lead in the Robert Wood Johnson Foundation supported Global Learning for Health Equity Network.



**Sandra Marin**

**Bio:** Sandra Marin is a bilingual diabetes educator for over seven years; she is also a grandmother raising four grandchildren in the Bronx. She originally came to Health People as a participant for the pre-diabetic program, which helped her lose weight - 120 pounds since she joined the organization! She has since been trained to facilitate the Diabetes Self-Management Program and National Diabetes Prevention Program, in English and Spanish, and is a fierce advocate for diabetes education, after seeing how much it has helped her, her family and her community.



**Maureen Miller, PhD**

Title: Infectious Disease Epidemiologist and Medical Anthropologist

**Bio:** I am a Columbia University trained and affiliated infectious disease epidemiologist and medical anthropologist. My career straddles academic and public spheres, and targets systems level change to disrupt the transmission of infectious diseases. My work, which focuses primarily on the social and structural drivers of infectious disease, integrates multiple scientific methodologies. I have worked with diverse stakeholders to evaluate both global and local responses to public health challenges to develop best practices, to share lessons learned, and to address information gaps with senior leadership, frontline staff, and community members. My work is broadly focused on health disparities, with subject matter expertise in the social determinants of health, population health and health systems strengthening. I am currently on contract with the New York City Department of Health and Mental Hygiene leading operations, planning and evaluation for the COVID-19 Health Equity Program.



**Chris Norwood** 

**CONNECT Conference Role:** Speaker

Title: Founder and Executive Director, Health People

**Bio:** Chris Norwood, a prize-winning author and healthcare advocate, was one of the first journalists to sound an alarm about HIV/AIDS in the early 1980s before it was widely recognized as a deadly epidemic. Norwood broke the story in Ms. Magazine that women with AIDS were routinely undercounted with their deaths attributed to other causes. She also authored the first book on women and HIV, "Advice for Life: A Woman's Guide to AIDS." That book, which came out in 1987, became the inspiration for her founding Health People (then known as Health Force) in 1990 as a women's prevention and support program. A pioneer in using peer education to enable communities to take control of their health, Chris has been recognized nationally and internationally for her work in HIV/AIDS and peer-delivered health education. In 2005, Chris was one of 1,000 women nominated worldwide for a special Nobel Peace Prize for women's work in community health.

**Title:** Director of Community Partnerships, at the Community Health Systems Lab at Albert Einstein College of Medicine, and Associate Director of the Community Health Worker Institute at Montefiore Health System

**Bio:** Renee Whiskey-LaLanne, MPH, MCHES, AE-C - Director of Community Partnerships, at the Community Health Systems Lab at Albert Einstein College of Medicine, and Associate Director of the Community Health Worker Institute at Montefiore Health System, is a public health professional with 13 + years of experience in program development and implementation in the field of population health. Her most recent work has focused on strategic development of comprehensive health education and Community Health Worker programs, addressing health and social needs of underserved and vulnerable populations in the Bronx. Currently Mrs. LaLanne's role is to oversee strategy and operations focused on working with communities to improve health outcomes. She completed her MPH at the Dornsife School of Public Health at Drexel University and is a Master Certified Health Education Specialist. Her professional goal is to amplify the voices of marginalized communities and harness those voices to drive meaningful change.

Throughout her career, Alzahraa has been working with and providing social services to many Arabic-speaking communities originally from the MENA region, including LGBTQ+ sub-community, in both the US and abroad. Title: CEO of African Life Organization

**Bio:** Known for her activism in fighting for social justice, she advocates for improving social and health services, immigration issues, housing, school education, and making referrals to community members to access services. Her years of experience in community development prompted her to create the African Life Center, ALC, in the Bronx, seeking to serve the African community. She conducted youth mental health leadership training in the community with support from the NYC Department of Health and Mental Hygiene. In her leadership, ALC was amongst the Taskforce on Racial Inclusion & Equity (TRIE) neighborhood coalition in response to the disproportionate impact of COVID-19 on communities of color finding solutions to challenges confronting their daily lives. She was instrumental in the creation of the Medina clinic within Harlem hospital for the underserved Muslim/African community. Ramatu collaborated with the Department of Minority Health Resource Center in Washington, D.C., and organized the fourth U.S. "African Health Conference 2016" in New York City. Founding member of the Bronx Multi Faith Advisory Group partnering with the New York City Department of Health- Office of Faith-Based Initiatives aimed at promoting better health in the Bronx. Ramatu is currently working with a research team funded by the National Institute of Health focusing on a valuable initiative on Ghanaian and Mental well-being in New York City to understand immigrant stress-related mental health.

**Bio:** Born in the Bronx, NY to immigrant parents from Honduras, Mirtha Gloria Arzu is a first generation Garifuna- American. Mirtha engaged in community service within the Bronx, including at Casa Yurumein Center, an organization founded by her mother M. Colon. Mirtha partnered with Garifuna members to create Miss Garifuna USA in New York. Mirtha has worked at Mount Sinai Hospital within the emergency room, obtained her Community Health Worker [CHW] certification from LaGuardia Community College and has participated in the Intouch CHW program with Columbia University. She has supported people from all ethnic and national backgrounds with applying for asylum, and connecting families to social services. Currently, Mirtha works for The Black Institute as their Community Organizer. One of her professional service-oriented goals is to create a CHW program for the Garifuna community in New York.

**Bio:** Ana Leon Bella has worked in movement for over 20 years as a dancer, fitness expert, and dance educator. She is a Laban Certified Movement Analyst (CMA), a Registered Somatic Movement Therapist/Educator (RSMT/E) with ISMETA, a Certified Polestar Reformer Instructor, a Certified Teacher of BodyMind Dance (CTBMD), and a Certified Moving for Life Instructor (MFLCI) working with people of any age affected by chronic health issues. I worked as a community health worker in the Healthy Start initiative at Bronx Community Health Network, Inc. for 5 years. As a CHW I worked with primary care teams in health centers to improve patient care and health outcomes. I specialized in Maternal and infant health, actively raising public health awareness and connecting families with resources. I am my community, that is one of my biggest strengths. I know and have experienced the challenges my people face and therefore dedicate my career to being part of the solution.



**Mary Charlson, MD**

**Title:** William T. Foley Distinguished Professor of Medicine and Chief of the Division of Clinical Epidemiology and Evaluative Sciences Research at Weill Cornell Medical College

**Bio:** Mary Charlson, MD, is the William T. Foley Distinguished Professor of Medicine and Chief of the Division of Clinical Epidemiology and Evaluative Sciences Research at Weill Cornell Medical College. She is a member of the American Association of Physicians and the Academy of Behavioral Medicine Research. Dr. Charlson is a methodologist and clinical epidemiologist and leads a multidisciplinary research team including clinical epidemiologists, informatics experts, and biostatisticians who have successfully completed numerous clinical trials and population-based studies with an emphasis on cardiovascular diseases. As a clinical epidemiologist, her work has focused on developing interventions targeted at improving outcomes in chronic illness. She developed the widely used Charlson Comorbidity Index. She has a long track record of successful RCTs among patients with chronic illness and has been the PI on 8 separate NHLBI-funded RCTS involving 2,725 patients. She is Co-PI on a PCORI-funded RCT to reduce unplanned hospitalizations in patients with high comorbidity.



## Rakim Covington (He/Him)

**CONNECT Conference Role:** Workshop Lead (Center for NuLeadership on Human Justice and Healing)

Title: Field Coordinator, Center for NuLeadership on Human Justice and Healing

**Bio:** Rakim Covington was born and raised in Brooklyn, largely by New York's foster care and group home system. He is an expert on what youth endure in the system and the effects of system involvement on young Black and Brown people. Moving from the system, to foster care, to a group home, Rakim was eventually released into his mother's custody before facing a state bid a few years later. With the void the system inevitably creates in any life, he sought the love he craved from family in the streets. After completing five years in prison, Rakim came to CNHJH and, despite having "felt like [he'd] heard it all before," kept returning to connect with CNHJH staff. In time, he considered the Center to be an extended family and devoted himself to expanding its reach. A doting father of a young daughter, he is passionate about meeting young kids he ran the streets with, offering his experience and advice on where they will end up if they fail to pursue their own positive potential. Rakim spearheads recruiting and consults on programmatic issues around violence prevention and youth empowerment work.



**Carmen Garcia**

**Title:** Community Health Worker Supervisor, Make the Road New York

**Bio:** Carmen Garcia is a Community Health Worker (CHW) Supervisor at Make the Road New York (MRNY). Originally from Ecuador, she has an Associate's Degree in Business Administration. She joined MRNY as a CHW in 2015 after completing the organization's training program. Carmen started at MRNY helping families with children under age 6 prevent and fight tooth decay through educational home visits. She currently supervises the Community Health Workers projects at MRNY. She conducts home visits to assess and minimize exposure to asthma triggers, provides asthma education, and connects patients and their families to social services at MRNY.

**Bio**: Joan Reibman, M.D. is a Professor of Medicine and Environmental Medicine at New York University/Bellevue Hospital and an attending in Bellevue Hospital, the largest public hospital in NYC. She is the Medical Director of the NYU/Bellevue Asthma Airways Environment Program, a program initiated to provide state-of the art care and research in asthma. She has been the Director of the Bellevue Asthma Clinic since 1991, when it was funded under a New York State Primary Care Initiative Grant. She has been the Medical Director of the Health and Hospitals Asthma and COPD Community Health Worker program since 2019, when she helped expand it into an adult as well as pediatric program with clear educational goals including: connecting patients to care; educating patients about asthma, medications and device use; mitigating unhealthy environmental exposures; and reducing adverse social determinants of health. She is also the Medical Director of the H+H World Trade Center Environmental Health, a program she began for treatment Center of Excellence in the WTC Health Program funded by law under the James Zadroga Health and Compensation Act. In addition, Dr. Reibman has been the recipient of multiple NIH awards to study mucosal immunity and ambient pollutants and was the Principal Investigator for the New York Consortium of the American Lung Association Airway Clinical Research Centers, a multi-center program for clinical trials in asthma and COPD.

**Bio:** Arnab K. Ghosh's research program focuses on climate change and health, and development of interventions to protect vulnerable populations against climate-amplified threats. His work is funded by the NIH, NSF, Environmental Defense Fund, and several other funding bodies. He previously served on a NAM-Burroughs Welcome Trust panel on climate and health and is the current co-chair of the national subcommittee of health policy and research at the Society of General Internal Medicine.

**Poster Title:** "Evidence-based urban greening programs – A mixed methods approach to improving environmental and climate justice"

**Abstract:** Recently, governments, climate scientists, and public health institutions have needed to respond, as well as provide solutions, to extreme heat impacts on urban communities. Often, these solutions provide short-term remedies, such as setting up cooling centers or distributing air conditioners. However, long-term strategies, such as reducing outdoor air temperature through urban greening, promise to have powerful cooling effects in cities.

Unfortunately, the cooling benefits of urban greening are often unequally distributed across communities, with many racially and socio-economically marginalized communities receiving less benefits. A lack of access to green space ultimately makes these communities more vulnerable to heat-related health issues. To alleviate these health issues, our team is designing a model to better predict the ideal tree species to grow in urban environments, and the best locations to plant them in.

However, as a group of scientists from various backgrounds, we also acknowledge that communities have important perspectives and preferences about tree planting in their own neighborhoods. Therefore, to respond to the specific needs of vulnerable communities, it is necessary for urban greening efforts to be rooted in climate justice— the connection of the climate crisis to broader social, racial, and environmental issues. With this in mind, we are seeking input from community-based organizations through an advisory board, focus groups, and interviews to understand the concerns, barriers, and questions they may have about urban greening, and its potential impact on health. Ultimately, we hope to create a framework for urban foresters and urban planners that is centered around community needs.

**Bio:** Devika Jutagir, PhD provides psychological services to patients with cancer at Memorial Sloan Kettering's Ralph Lauren Center in Harlem and conducts research to increase access to cancer care.

**Poster Title:** "Implementation of psychosocial distress screening to detect comorbid psychosocial distress in NYC municipal hospital patients diagnosed with cancer"

**Abstract:** Diagnosis and treatment of cancer can be a significant source of distress for patients, and can adversely affect treatment adherence and health outcomes, including survival. However, less than 10% of cancer patients who experience psychosocial distress seek or receive treatment. This project will design and pilot a psychosocial distress screening protocol within Metropolitan Hospital Center's oncology practice (60% Black, 40% Hispanic; 40% English-speaking, 35% Spanish-speaking). We will conduct and rapidly analyze in-depth interviews with staff members and cancer patients at Metropolitan Hospital Center and use this information to develop a linguistically and culturally sensitive model for screening cancer patients for distress and referring patients to appropriate resources to address distress and essential needs. Our long-term goal is to eliminate treatment disparities for underserved patients with comorbid psychiatric disorders and cancer.

**Plans/ideas for community engagement:** Plans for the study were presented to the COMMUNITY Stakeholder meeting and the Linking Community Advisory Board (CAB) of the COMMUNITY Center's CONNECTOME Core. The Linking CAB provided feedback on the study design and the guide to be used to interview patients at Metropolitan Hospital. Feedback was integrated into the study protocol and study materials.

**How community-members can become involved:** We will consult community members during interpretation of research findings. Community members can also be involved in communicating about the research findings to populations who would benefit from knowing about the results.



Nadia Liyanage-Don, MD, MS

**Bio:** Dr. Liyanage-Don is a member of the research faculty at the Center for Behavioral Cardiovascular Health. Her research focuses on the design and implementation of behavioral health interventions aimed at treating and preventing chronic diseases. She is specifically interested in the application of remote patient monitoring and other digital health technologies to improve treatment adherence and clinical outcomes for cardiovascular and respiratory conditions, particularly among minoritized patient populations. Dr. Liyanage-Don received her undergraduate degree from Harvard University and her medical degree from the Boston University School of Medicine. She completed residency training in internal medicine at the New York Presbyterian Hospital/Columbia University Irving Medical Center. She subsequently completed a postdoctoral fellowship in general internal medicine at the Columbia University Irving Medical Center, during which she also earned a Master of Science degree in Epidemiology from the Columbia Mailman School of Public Health.

**Poster Title:** "Feasibility and Acceptability of Implementing Systematic Medication Nonadherence Screening for Multiple Chronic Conditions into Clinical Care"

**Abstract:** Medication adherence is a cornerstone of chronic disease prevention and management, yet many patients do not take their medications as prescribed. There are also significant disparities in medication adherence, with worse rates consistently seen in minorities and those of lower socioeconomic status. While guidelines recommend assessing for medication nonadherence as part of standard care, this has not been systematically integrated into clinical practice, especially for patients with multiple chronic conditions. Little is known about barriers and facilitators to screening for medication nonadherence in real-world settings. Furthermore, there are no validated tools for measuring adherence to multiple medications simultaneously.

This study will assess the feasibility and acceptability of implementing a validated medication nonadherence questionnaire into clinical practice in a group of socioeconomically diverse patients with multiple chronic conditions. We will also examine how social determinants of health impact the feasibility, acceptability, and uptake of screening. Finally, we will assess the concurrent validity of the medication nonadherence questionnaire when used for patients prescribed multiple medications.

Focus groups with patients and physicians will be used to identify barriers, facilitators, and contextual factors affecting implementation of the medication nonadherence questionnaire. Themes explored in patient focus groups will include feasibility, acceptability, and appropriateness of questionnaire implementation, as well as interpretations of questionnaire items. Themes explored in physician focus groups will include importance of systematic screening for medication nonadherence, perceptions of questionnaire implementation, and clinical applications of questionnaire responses. The results will be used to adapt available measures to screen for nonadherence to multiple medications simultaneously.

**Bio:** Dr. Oviedo Hilario completed their Internal Medicine training in 2017 and am deeply committed to improving the health and well-being of patients and the community. As part of these efforts, we will soon implement the Lifestyle Medicine Program in our Hospital, which I will be directing. In partnership with Mott Haven Community Partnership, I have conducted workshops within the community, focusing on lifestyle changes that can positively impact health outcomes. By working in this underserved community, I have realized the health disparities that they face and the need for better resources and policy changes that will eventually translate into better health outcomes and the important role we play as advocates for our patients.

**Poster Title:** "Focus group evaluation about barriers and facilitators for healthy diet at a safety net Hospital, and role of EFNEP and Community Advisory Board to implement dietary learning in our community"

**Abstract:** Cardiovascular health in the U.S. is suboptimal, in part due to poor nutrition. There Is a critical need in our community for better nutrition-related knowledge and access to healthy foods, however diet is complex and tied to multiple factors, including cultural identity. There are significant gaps in knowledge regarding the key determinants of food choices in our South Bronx community. A better understanding of these influences will provide the foundation for a research project intended to improve diet quality especially among those with multiple CVD risk factors. We propose to conduct focus groups with a group of patients from our primary care clinic. We will directly engage our community as our research follows the principles of community based participatory research.

**Bio:** Dr. Alexie Puran previously served as the Chief of Pediatric Emergency Medicine and Associate Director of the Emergency Department at NYC Health + Hospitals/ Harlem. Dr. Puran is an Assistant Professor of Clinical Pediatrics at Columbia University's Vagelos College of Physicians and Surgeons. Dr. Puran is board certified in both Pediatrics and Pediatric Emergency Medicine. He earned his Doctor of Medicine at Albert Einstein College of Medicine after graduating from Stony Brook University with a double major in pharmacology and political science. He also earned a master's in business administration from the University of Rochester. Dr. Puran completed a residency in Pediatrics at Jacobi Medical Center and a fellowship in Pediatric Emergency Medicine at Strong Memorial Hospital. Dr. Puran is passionate about improving the patient experience as well as the physician experience, and serves as the Director of Harlem Reads, an innovative program which promotes literacy for patients who are cared for in the Pediatric Emergency Department.

**Poster Title:** "Attack Asthma In Kids: Improving Asthma Disparities by Targeting Health Literacy for Children and Families in Harlem, New York City"

**Abstract:** According to NYS DOH, Harlem's hospitalizations/Emergency Room visits for childhood asthma more than double NYC as a whole, highlighting disparities. Despite availability of a wide range of controller and reliever therapies, uncontrolled asthma remains a challenge and is associated with increased morbidity and mortality. Allergies is a risk factor for asthma with 80-90% of children who have asthma also suffer from allergies. With successful management of allergies, asthma becomes easier to control.

To improve asthma control and manage allergy challenges in children, a new health campaign targeting health literacy has been designed entitled, Attack Asthma in Kids. Unlike many sociodemographic variables, health literacy can potentially be addressed in the health care setting. Attack Asthma in Kids engages asthmatic children/families with a new low health literacy asthma action plan.

This study will span 2 years and will test the hypothesis: asthma and allergy control can be achieved with the use of a low health literacy asthma action plan. Opportunities for engagement with community-based partners will include: Facilitate community participation with recruiting parents/guardians with a child diagnosed with asthma in completing a brief survey assessing attitudes and preferences to the newly created low health literacy asthma action plan at local meetings or events.

Provide technical assistance and guidance in program planning and development with a local school for a cohort of 30 students to be followed for a 6-month period. Disseminate and communicate educational and awareness resources pertaining to the study. Establish relationships to help provide long-term support in sustaining health initiatives.

**Bio:** Dr. Amil Tan completed his Ph.D. degree at the CUNY Graduate Center. Dr. Tan is a registered nurse by profession. He teaches public health nursing courses for undergraduate students. His past research projects include addressing long-term care reform efforts on outcomes sensitive to nurses and the older adult population. Projects have included exploring nurse practice environment, moral distress, and nurse retention in long-term care; investigating the impact of a nurse-led interdisciplinary heart failure team program on rehospitalization and nurse-patient interaction among older adults with heart failure in a nursing home and being involved in understanding resident-to-resident aggression in assisted living facilities. He is also interested in psychometric evaluation. He has done research on validating long-term care moral distress questionnaires and collaborated in developing and testing the Lucidity in Dementia and Neurological Impairment Measure (LD-NIM) questionnaire. Dr. Tan is currently involved in research projects addressing social health determinants and chronic diseases such as diabetes, obesity, and heart failure. He is also leading a project to reduce falls and injuries among hospitalized older adults with cancer.

Poster Title: "Using ZIP Code Level Social Determinants of Health (SDOH), Diabetes, and Obesity in a Primary Care"

**Background**: A combination of chronic diseases like diabetes and obesity comorbidity remains a significant health burden. The New York State Department of Health (2018) reported there are about 900,000 New Yorkers with diabetes. In that year, the adult obesity rate in Queens country was 22% and rate for diabetes rate was 11%.6. Studies linking SDOH to diabetes and obesity management and dependents include social background, social insecurity, poverty, education, health insurance, food security, social isolation, health literacy, and housing status.

**Aim**: Investigate the role of ZIP code level SDOH on rates of patient-level diagnoses and markers of type 2 diabetes mellitus (fasting blood glucose levels, HbA1c) and obesity (BMI).

**Methods**: The proposed retrospective cross-sectional will analyze the electronic health records (EHR) of persons with diabetes and/or obesity. The (KFF) SDOH conceptual framework guides this study. The ICD-10 code diagnosis from the EHR of a primary clinic will be merged with and nested within ZIP code level SDOH variables obtained from the New York City Neighborhood Health Atlas, New York City Department of Parks & Recreation, and the 2020 Census. IRB approved 2023-0229-Hunter.

**Plan of Analysis**: The SDOH variables will be converted into proportions, and general linear regression analysis will be used to explore association between SDOH and markers of type 2 diabetes mellitus (fasting blood glucose levels, HbA1c) and obesity (BMI) while controlling for age, sex, race, ethnicity, and comorbidities.
